#### Proposed 2023-2024 School Year Calendar Discussion Overview

Staff: Dr. Cheryl Proctor and Daniel Cogan

Staff provided an overview of the proposed calendar and the considerations taken in the development of the calendar. It was noted that three days were added for professional development that would be required for teachers at schools with certain designations (TSI & CSI schools) and optional for all other teachers.

Board Directors asked questions. There was discussion regarding the number instructional hours for students by grade, and the list of religious and cultural days to avoid. It was noted that it is legally complicated to determine which dates to include, and that there will be multiple tiers of communication regarding the selected dates.

#### **Discipline Data Update Overview**

Staff: Dr. Renard Adams and Jey Buno

Staff provided an overview of discipline data trends and goals, student supports, and the multiple-tiered system of support (MTSS). It was noted that the district's data reflects the national rate of discipline for students by race, with black students being disciplined three times more than white students. Staff provided an overview of MTSS, including data monitoring, professional development, social emotional learning, and collaborative school discipline. Board Directors asked questions, including how feedback is gathered and how we know if the system is supports are working. There was discussion regarding the different tiers of MTSS and how students and partners access the program.

An overview of the discipline data, including referral data by grade, by race and special education designation, and exclusion data was provided. It was noted that not all referral resulted in discipline and that the data has been consistent over a three-year period. Staff shared that moving forward the plan is to remain student focused, to continue to build on MTSS, instructional framework, and professional development. Board Directors asked questions. There was discussion regarding accountability for over referring teachers.

Board Chair Andrew Scott adjourned the meeting at 8:12 pm.


