### **Introductions**

Attendees went around the room and introduced themselves, including anyone who was in attendance virtually.

#### Americans with Disabilities Act (ADA) Transition Plan

Presenters: Dan Jung, John Lyons, and Sarah Miller

Staff shared an overview of current accessibility across the district for persons with disabilities and the regulatory context of Americans with Disabilities Act (ADA) Compliance. It was noted that the ADA compliance regulations are a minimum and do not encompass the full vision for district accessibility. Sarah Miller shared about her daughter who is a student at Portland Public School and who has muscular dystrophy. She shared what recess is like for her daughter at a school with a playground that is not accessible for students with disabilities, noting ways that even when all ADA requirements are met, the playground would still not meet the needs of students with disabilities. Staff highlighted some of the accessibility focuses that the district has which go beyond the ADA act requirements. There was discussion regarding the plan phasing timeline. It was noted that the ADA transition plan only speaks to

the federal ADA requirements and that it is prohibited from including anything over the requirements. Any additional accessibility scopes are included in the long-range facilities plan. Staff will revise the language regarding the implementation timeline based on Committee feedback and bring the plan back to the Committee for consideration.

### Portland Parks and Recreation (PPR) Intergovernmental Agreement (IGA)

Staff provided an overview of the Intergovernmental Agreement (IGA) that was negotiated with Portland Parks and Recreation (PPR) regarding sports-related use of PPR and Portland Public Schools properties. It was noted that the real estate negotiations with Portland Parks and Recreation will begin in January, and that the negotiating who pays for what improvements is expected to be challenging. Staff highlighted the changes from previous agreements. There was discussion regarding how the agreement was reached and next steps.

Staff provided a brief overview of the Master Plan creation process and the highlighted details from the Lincoln modernization master plan, including the value engineering process and swing spaces options that were identified for use during construction. Staff summarized the problems encountered with athletics at West Sylvan, including permitting issues. A summary of the potential path forward for the currently approved scope of work, as well as projects not covered in the modernization, was provided. The committee asked questions and provided comments about the plan. There was a brief discussion regarding how bond contingency funds can be moved to other projects.
