A Regular Meeting of the Board of Education came to order at 6:06pm at the call of Chair Tom Koehler in the Board Auditorium of the Blanchard Education Service Center, 501 N. Dixon Street, Portland, Oregon.

Savannah Mullen and Resyka Smith: asked the Board to change the name of King Elementary back to the original Martin Luther King Jr. Elementary School.

Public Comment

- Teressa Raiford: stated that she had requested an audit last year regarding Grant and SEI as kids were failing in the school system and no leadership at PPS cares about their outcomes. There is no accountability or oversight on school funding. PPS does not give a damn about their children. Parent should get in touch with *Don't Shoot Portland*.
- Ray Leary: If the Board would like to have a discussion, he would be happy to participate. Overtalk is not the only way to get a point across.
- Thor Presley: stated that Oregon has a law about retrieving rainwater and that you could go to jail if you took rain from Oregon. He asked who was responsible for all the water in the schools. He asked the Board to explain to him who controls what goes in the water if it comes from the sky.
- Kara Cauley: has a third grade daughter at Ainsworth and she was surprised at how many teacher absences occur. They were allowed 15 days a year: sick or family reasons, professional development, and PPS mandatory meetings. She has a problem with that and asked that teachers be kept in the classroom.
