SUBJECT: Community Use of Buildings (CUB) – Revisions to the Policy 3.30.010-P

I. BACKGROUND

In August 2016, PPS board adopted an updated Community Use of Buildings (CUB) Policy 3.30.010-P. The Superintendent updated the related Administrative Directives 3.30.011-AD and 3.30.012-AD shortly thereafter. Before this update, the policy, administrative directive and fee schedule had not been revised in approximately ten years.

In February 2019, the Scott Elementary School PTA (Scott PTA) outlined to the Board the hardships and disadvantages of the required payment of custodial services for events and fundraisers held on weekends and/or days when custodial staff is otherwise not in the school building. The Scott PTA represented that the costs associated with custodian coverage significantly impacted the school's fundraising efforts and asked that the Board consider providing "custodial waivers" to Title I Schools annually to mitigate this impact.

The Board asked staff to study the impacts of such a request and to draft an amendment to the CUB Policy 3.30.010.P specifically outlining a fee waiver framework for such events at lower socio-economic status schools.

On March 14, 2019, staff presented proposed policy revisions to the Board's Policy Committee, where they were approved and referred to the full Board for a first reading.

Attached is both clean and redlined copy of the approved policy revisions.

II. RELATED POLICIES/BEST PRACTICES

Providing a limited number of custodial fee waivers to PPS Title I schools, schools with a majority of historically underserved students, and schools identified for improvement as designated by the District will allow these specific schools to hold events outside school hours without the financial impact of custodial fees.

Assuming six (6) hours of custodial coverage is provided without charge annually to up to thirty-two (32) schools, as was discussed at the Policy Committee, the fiscal impact will be approximately \$10,000.

Staff aims to revise the Administration Directive 3.30.011.AD in April so that the limited custodial waivers can be issued for 2019/20 school year. Staff will notify the impacted schools of the process for redeeming waived fees once the administrative directive has been revised.

RESOLUTION No. XXXX

Amend Community Use of School Buildings and Facilities Policy.

RECITAL

A. WHEREAS in 2016, the PPS Board adopted an updated Civic Use of Buildings (CUB) Policy P3_30_010-P;

B. WHEREAS in February 2019, the Scott Elementary School PTA relayed to the Board of Education the hardships and disadvantages created by the cost of custodial services charged for events and fundraisers held on weekends and/or days when custodial staff is otherwise not in the school building;

C. WHEREAS the Board of Education determined that there is benefit to the District to provide a limited number of waivers annually to cover custodial fees at PPS Title I schools such as Scott, as well as schools with a majority of historically underserved students, and school specifically designated by the District for improvement;

D. WHEREAS the details of administrating limited waivers for custodial coverage will be further developed through an amendment to Administrative Directive 3.30.011 AD.

RESOLUTION

THEREFORE BE IT RESOLVED:

1. Policy 3.30.010-P is amended to allow a limited number of custodial fee waivers annually to PPS Title I schools, schools with a majority of historically underserved students, and school specifically designated by the District for improvement and to direct the Superintendent to amend Administrative Directives 3.30.011 AD to provide a clear process for administering such custodial fee waivers.
