#### JANUARY 26, 2016 MEETING OVERVIEW

A Regular Meeting of the Board of Education came to order at 6:02pm at the call of Chair Tom Koehler in the Board Auditorium of the Blanchard Education Service Center, 501 N. Dixon St, Portland, Oregon.

## **Student Testimony**

Karina Autar, Kaiya Yonamine, Y Le, and Jessica Yu, all members of ALLY (API Leaders for Liberation of Youth), spoke on the importance of ethnic studies in order to learn the traditions and cultures of various ethnic peoples. Ethnic studies result in higher student grades and literacy skills, and also closes the achievement gap. ALLY launched their ethnic studies campaign in October 2015 and the students were currently drafting a resolution that they will present to the Board at a later date. They would like to schedule a meeting with each Board member to hear their perspectives.

## Public Comment:

Ethan Medley: Board member for the Portland Village Charter School, provided an update on the school, adding that they were interested in working around issues they have with the District, and invited the Board to visit the school.

- Jennifer Whitten: in regards to the proposed boundary changes on the west side, requested that Bridlemile remain in the Lincoln feeder pattern. Travel time would be much higher if students attended Bridlemile and then had to go to Gray Middle School and Wilson High School.
- Matt Zaffino: parents in the Council Crest neighborhood have worked hard to come up with solutions to the overcrowding of schools on the west side. Boundary changes should happen sensibly, without destroying community schools, without eliminating walkability to schools and without creating additional, harmful and unnecessary traffic. He requested that the Board not make any changes to west side boundaries until 2017.
- Demian Heald: requested that the protocol for boundary changes be altered. It would have been a great service if a formal process was decided on in advance. He asked the Board to consider the geography on the west side as the current proposals could result in the traffic for three schools being channeled into one road.

Hilary Evart: spoke on the disciplinary hearing her son had and the principal denying them due process.
