Committee Discussions

SUN School update

Staff: Dani Ledezma, Meanroth Ny, Lidia Lopez Gamboa

Staff provided an overview of the current SUN programming, highlighting the supports that are provided by the program, the program redesign that is in progress, and areas for improved services.

- SUN provides mental health support and distributes food boxes to families.
- SUN supports the instructional framework and provides culturally responsive programming.
- SUN services are provided by SEI, IRCO, Latino Network, Impact NW, and Portland Parks and Recreation.

 Portland Public Schools would like the program to align to the school year schedule, to serve kindergarteners, and to align their professional development for sun staff with district professional development.

Legislative Update

Staff: Lisa Merrick and Courtney Westling

Staff shared that the 2022-23 legislative agenda is being drafted, noting that it is expected to be before the Board for approval in mid-December. The Committee discussed areas of legislative action to potentially be included on the agenda.

- The Legislative Agenda provides categories of focus that are aligned with board goals and District Vision. It is not meant to be an exhaustive list.
- Potential areas of action to be included on the agenda: Advocating for funding that allows for full
 implementation of the Quality Education Model (QEM) and funding for annual inflation; and
 violence reduction advocacy, including providing mental health supports and gun regulations.

Update: Right to Return

Staff: Courtney Westling and Lisa Merrick

Staff provided an overview of the Right to Return program, including the current practice and the goal for implementation of a formal process. Staff is working with other districts to construct a Right to Return Memorandum of Understanding which will set up a process for allowing families to come back to Portland Public Schools when they move out of the district. The goal is to create a more formal process, in an effort to make it easier for families to navigate.

Cully Tax Increment Finance (TIF) Plan

Staff: Jonathan Garcia

Staff provided an overview of the Cully Tax Increment Finance (TIF) and how it would affect Portland Public Schools, noting that the City of Portland is considering a Tax Increment Financing plan which is intended to improve and revitalize communities.

- Meant to improve and revitalize communities.
- Land and business owners can request portions of TIF funds for capital projects. Projects cannot be directly for education services.
- Portland Public Schools is the steward of three properties within the Cully TIF boundaries.

Update: Multnomah Educational Service District (MESD) Board Legislative Dinner

Staff: Courtney Westling

A Board Legislative Dinner is being hosted by Multnomah Educational Service District (MESD), which will follow a planning meeting. The intent of the meeting and dinner is to plan an agenda for legislative action so that the area school districts can present a united front on common issues in Salem during the legislative season.

Bias Incidents

Staff: Dani Ledezma

Staff shared that the District tracks bias incidents and that there is currently no way for the police bureau to investigate any incidents of bias when there isn't a clear victim, resulting in crimes not being

investigated. Staff has worked with the city to draft legislative language to help put in place a better response system to bias incidents.
